

RESOLUTION/ORDINANCE TO SET MILL LEVIES

(Pursuant to 39-5-128, C.R.S. and 39-1-111, C.R.S.)

A RESOLUTION / AN ORDINANCE LEVYING PROPERTY TAXES FOR THE YEAR 2024, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE OAK CREEK FIRE PROTECT,

COLORADO, FOR THE 2024 BUDGET YEAR.

WHEREAS, the Board of Directors of the Oak Creek Fire Protection Distri, has adopted the annual budget in accordance with the Local Government Budget Law, on January 11, 2024 and;

WHEREAS, the amount of money necessary to balance the budget for **general operating** purposes from property tax revenue is \$ 1,201,264, and;

WHEREAS, the Oak Creek Fire Protection Dist finds that it is required to temporarily lower the operating mill levy to render a refund for \$ 0.00, and:

WHEREAS, the amount of money necessary to balance the budget for **capital expenditure** purposes from property tax revenue approved by voters or at public hearing is \$ 0.00, and;

WHEREAS, the amount of money necessary to balance the budget for voter-approved **bonds and interest** is \$ 0.0, and;

WHEREAS, the 20 24, valuation for assessment for the Oak Creek Fire Protection District as certified by the County Assessor(s) is \$ 86,186,300,

NOW, THEREFORE, BE IT RESOLVED/ORDAINED BY THE BOARD OF DIRECTORS

OF THE OAK CREEK FIRE PROTECTION DIST, COLORADO:

Section 1. That for the purpose of meeting all **general operating** expenses of the Oak Creek Fire Prot during the 2024 budget year, there is hereby levied a tax of 13.93% mills upon each dollar of the total valuation for assessment of all taxable property within the Oak Creek Fire Prot for the year 2024.

Section 2. That for the purpose of rendering a refund to its constituents during budget year 2024, there is hereby levied a **temporary tax credit/mill levy reduction** of 0.0 mills.

RESOLUTION/ORDINANCE TO SET MILL LEVIES - Con't.

Section 3. That for the purpose of meeting all **capital expenditures** of the Oak Creek Fire Protection D during the 2024 budget year, there is hereby levied a tax of 0.0 mills upon each dollar of the total valuation for assessment of all taxable property within the Oak Creek Fire Protection for the year 2024.

Section 4. That for the purpose of meeting all payments for **bonds and interest** of the Oak Creek Fire during the 2024 budget year, there is hereby levied a tax of 0.0 mills upon each dollar of the total valuation for assessment of all taxable property within the County/City/Town/District for the year 2024.

Section 5. That the Chief Brady Glauthier is hereby authorized and directed to immediately

certify to the County Commissioners of Routt County(s), Colorado, the mill levies for the Oak Creek Fire Protection D as hereinabove determined and set, or be authorized

and directed to certify to the County Commissioners of Routt County(s), Colorado, the mill levies for the Oak Creek Fire Protection District as hereinabove determined and set,

but as recalculated as needed upon receipt of the final (December) certification of valuation from the county(s) assessor(s) in order to comply with any applicable revenue and other budgetary limits.
